Possession of a price list is not an offer to or agreement to sell. We reserve the right to change prices without notice. We are not responsible for typographical errors. In the event a price or description is found to be incorrect, the correct information will be communicated to you when the order is received.

Credit Terms: Open account status is only granted after a completed credit application is received and approved.

Payment Terms: Terms for open account are net 30 days. Terms for orders without open account will be determined by Silver Street, Incorporated on an order-by-order basis and may require prepayment or a 50% deposit with order and the balance prepaid before shipment.

Orders: Orders must be in writing. Faxed orders are acceptable. Processing of orders will not begin until a signed acknowledgment is received.
